Good morning,

Below was my request made in 2023 for our new training line item fund, which is why we believed items such as a red-man training suit, targets, cones, other training equipment, etc would be allowed to be spent from this fund.

That said, if the training line item fund cannot be used to pay the invoice for the suit, I am requesting a transfer from animal control supplies line item to pay part of the full invoice of the red-man suit. We are requesting \$2,500 to be taken from animal control supplies.

2023 request

Fund: ??? Training fund (No current line item)

The Sheriff's Office does not currently have a training fund. We are therefore requesting to create a training fund for the year 2024 and beyond. Training is not just a necessity for law enforcement, but is an expectation of our citizens (as it should be) and training cost money. We have historically utilized our commissary account for training supplies and other costs as it pertains to training our personnel. While we certainly have no problem supplementing training costs with commissary (as the statute refers to), we do not believe commissary should continue to sustain total training cost to our agency in this day and age. It should be noted that much of our training is conducted "in-house" by our own personnel to limit significant cost, but every aspect of training cannot be sustained "in-house". Training cost include but are not limited to; Travel and lodging to training sites, class/course fees, taser training cartridges, ammunition and targets, traffic cones, among others.

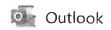

Good Afternoon County Council Members,

As I've shared with I believe most if not all of you, it is my goal to reach 47 deputies with our agency. We are currently at 42. I asked our grant committee to apply for an extension on the COPS grant we received a few years ago. Obviously, with the understanding in order for this to take effect, the council would have to agree.

That said, the extension was granted for a period of 36 months, for five deputies at \$125,000 per Deputy for that 36 month period.

I believe the cost per Deputy is around \$100,000/\$110,000 a year with salary, insurance, etc. (the auditor's office would have to confirm any exact figures). Figures above basically equate to approximately \$41,000 a year we would be receiving from the grant for three years (for each additional deputy), at which point the council would have to take over full cost of the deputies.

I'm getting confirmation, but I believe the grant pays 75% year one, 50% year two, 25% year three (Same as the original grant). You can look at it either way I suppose... On average it's about half per year, but it starts higher year one and decreases down to year three.

In short, we would be getting additional deputies at or just below half the cost for three years.

While I understand five additional deputies is a big ask, we would appreciate all we could possibly receive (2, 3, 4), considering our needs, a lower cost to the county, as well as our efforts to apply for and receive this grant funding to reduce the strain on county tax payers.

This said, I do not want this to negatively impact the agreed upon salary increase. I know some may ask which do you want? Simple answer – I want both and I believe we need both. This conclusion comes from 22 years of experience at our agency working at various levels, as well as researching and comparing numbers with other agencies.

A brief "in our backyard" comparison (for those who like numbers):

*NOTE – This is **NOT** a knock at THPD. They have great officers who are well-trained and who do a great job... it is meant for comparison purposes only in terms of numbers!

THPD current staffing numbers as compared to their average call volume in a given year correlates to appx 410 calls per a THPD Officer.

Our (Sheriff's Office) call volume and number of deputies correlates to appx 490 calls per VCSO Deputy.

We cover about 10 times the square miles than the TH Police Department covers, which obviously means longer response times, longer time spent on initial calls, longer it takes a detective to go speak to someone on a case, etc etc.

My goal is to get to 47 deputies (currently we are at 42). Based on this whole numbers game above, we would need 51 deputies to be of an equal comparison to the Terre Haute police department in terms of numbers. However, I'm not insinuating we need 51 deputies.... I would be comfortable with 45 (an additional 3), with a long-term goal of 47 (in the next 2-4 years).

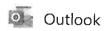

Sheriff Fell, I hope this answers all your questions.

Good Afternoon Levi,

Each position is for \$125,000 as we discussed. It is correct that each position has a condition of retention of 36 months, plus an additional 12 month period after the conclusion of the award. As you have applied for a Grant Award Modification, the Grant Award Modification conditions specify that "awards may be extended a maximum of 36 months." However, if you were unable to hire the remaining positions within a year, then you will not have sufficient time to complete the 36 months condition.

The \$125,000 is able to be withdrawn as it is used. So in order to claim funds for the position once it is hired, on the Federal Financial Report you would fill in the expenses that were occurred during that period, once it has been accepted, then you could do a draw down from ASAP.

AN ORDINANCE ADOPTING THE 2025 SALARY SCHEDULE AND COMPENSATION POLICIES FOR THE CORRECTIONAL/ DETENTION /BUILDING SECURITY OFFICERS OF VIGO COUNTY

WHEREAS the County of Vigo Indiana is an Equal Opportunity Employer, and

WHEREAS it is the intent of Vigo County Indiana to comply with applicable federal and State of Indiana employment laws and regulations, and

WHEREAS Indiana Code 36-2-5-3 Section 3. (a) establishes that the county fiscal body shall fix the compensation of officers, deputies, and other employees whose compensation is payable from the County General fund, County Highway fund, County Health fund, County Park and Recreation fund or any other fund from which the county auditor issues warrants for compensation with the exception of the Convention and Visitors Bureau and Community Corrections funds This includes the power to:

- (1) fix the number of officers, deputies, and other employees:
- (2) describe and classify positions and services:
- (3) adopt schedules of compensation; and:
- (4) hire or contract with persons to assist in the development of compensation.

NOW THEREFORE it is ordained as follows:

SECTION 1. FLSA exempt and non-exempt classifications are hereby adopted for the purposes of calculating overtime for employees holding non-exempt positions. Employees holding exempt positions are not cligible for FLSA overtime or FLSA compensatory time.

SECTION 2. The Vigo County Personnel Policy, effective September 12, 2017, and all adopted addendums, are hereby adopted by reference; compliance with such policies are a term and condition of County employee compensation; County employees are entitled to pay for leave policies specified in the Vigo County Personnel Policy; and the County Auditor shall not issue pay warrants for paid leave not specified in the Vigo County Personnel Policy.

SECTION 3. Commencing January 1, 2025, the following salary schedule, not to exceed the amount listed, shall be in full force and effect for all Vigo County Correctional Detention Officers ("Correctional Officers") of Vigo County, which includes the Vigo County Jail, Vigo County Juvenile Detention Center and Vigo County Building Security as follows:

SECTION 4. All full-time Vigo County Correctional Officers (Jail, Juvenile Detention Center and Building Security), shall receive longevity pay annually commencing at the beginning of the calendar year of his/her 2nd year in accordance with the attached longevity schedule. For each subsequent year of service, they shall receive longevity pay up to the maximum of \$6,250.

SECTION 5. All full time Correctional Officers employed by the Vigo County Jail and those employed as Building Security will receive \$1,500.00 per year clothing allowance.

SECTION 6. All full time Correctional Officers employed by the Vigo County Jail, Juvenile Detention Center or as Building Security are eligible to receive an annual stipend of \$1,500 in order to aid in the attraction and retention of employees. To be eligible for the stipend an employee must have continuous serve for 6 months prior to receiving the stipend. Equal installments of the stipend will be paid in June and December.

SECTION 7. Two (2) Juvenile Detention Officers will receive a \$1,000 Stipend each for being Trainers.

SECTION 8. Full-time employees in PERF covered positions determined ineligible for PERF per state statute shall receive a stipend equal to the defined employee contribution rate (3.00%) to be paid in each pay period.

SECTION 9. Temporary employees, part-time employees, and extra help for the positions of Vigo County Jail Correctional Officers, Juvenile Detention Officers, and Building Security shall be compensated at a rate of \$22.06 per hour. Process Servers shall be compensated at a rate of \$17.00 per hour. Those employed as any part-time employee Correctional Officer, Juvenile Detention Officer or Building Security will be limited to twenty-nine hours per week.

SECTION 10.

(A) <u>VACATION PAY</u>

Correctional Officer Employees covered by this ordinance shall receive paid vacation as established in the Vigo County Employee Handbook.

- (B) <u>PERSONAL DAYS</u>
 Correctional Officer Employees covered by this ordinance shall receive personal days as established in the Vigo County Employee Handbook.
- (C) <u>SICK DAYS</u>
 Correctional Officer Employees covered by this ordinance shall receive paid sick days as established in the Vigo County Employee Handbook.
- (D) HOLIDAYS

 Correctional Officers of the Vigo County Jail and Juvenile Detention officers who work on recognized holidays shall be paid for all hours worked and will be compensated at the holiday hourly rate for eight (8) hours of their shift on said holiday.

SECTION 11. The illegality or invalidity, for any reason, of any of the sections of this ordinance, or parts thereof, shall invalidate only such section or sections as are so determined to be illegal or invalid, and any such invalidity shall have no effect on the remaining sections of this ordinance.

SECTION 12. This ordinance does not apply to employees who are covered by collective bargaining agreement, merit officers of the Vigo County Sheriff's Department, Compensation established by other Vigo County Salary Ordinances, persons whose compensation is governed by statute, persons whose compensation is established by a state agency or grant, and elected officials.

SECTION 13. The compensation amounts that are listed as annual appropriation amounts and the calculation of the bi-weekly or hourly compensation rates may result in a slight variation and will not be adjusted at the year end.
