Pledge of Allegiance. Mark Clinkenbeard called the meeting to order at 9:05a.m.

Review of minutes/claims. Chief Deputy Auditor Morgan Elkins presented the Board with the minutes for the meeting from April 8th 2025 for approval. Mark Clinkenbeard noted he was not present for the April 8th Meeting. Chris Switzer made a motion to approve the April 8th, 2025 minutes as presented. Mike Morris seconded the motion. West Central Indiana Partnership

West Central Indiana Partnership Vice President of Regional Engagement Josh Alsip gave a presentation discussing the goals of the initiative. He said the organization is continuing to work on a plan for economic development for the region. Vermillion, Vigo, Sullivan, Clay, and Parke counties would be involved in the partnership. He discussed several programs to develop the local workforce by assisting area interns. The goal is to keep local talent from leaving the area. Professional development events will be held throughout June and July. Josh also discussed efforts to gain regional support for a proposed disc golf course at

Fowler Park. He said the park had received a grant for the course. Josh said the initiative is working on a regional census to gather data about public sentiment of the five county region. Mark Clinkenbeard thanked the Chamber for their efforts. Chris Switzer noted efforts by the commissioners to financially back the Chamber of Commerce.
