REGARDING AN ADDITIONAL APPROPRIATION

The Vigo County Council (the "Council") met at a duly called and authorized meeting of the Council held on the date set forth below, such meeting being called pursuant to a notice stating the time, place, and purpose of the meeting received by all the Council Members and published pursuant to statute, and the following were made, seconded, and adopted by a majority of those present at the meeting, which constituted a legal quorum of the Council:

**WHEREAS**, the Lost Creek Township Fire Protection District (the "District") has determined that it is necessary to appropriate more money than what was appropriated in the annual budget; and

**WHEREAS**, after notice and a public hearing thereon, the Council desires to approve the following appropriations.

**NOW THEREFORE, BE IT ORDAINED** by the Vigo County Council, being the fiscal body for the Lost Creek Township Fire Protection District, Vigo County for budget purposes, that:

**Section 1. Additional Appropriations.** The following additional appropriations are hereby made in excess of the budget for the District for the current year, subject to the approval by the Indiana Department of Local Government Finance:

**RE: Request for Appropriation of Funds**

Dear Honorable County Council Members,

I am writing to formally request to be placed on the agenda for the next County Council meeting to discuss the transfer of **\$200,000.00** from the **Juvenile Justice Center Non-Reverting Fund (4959.02101.000.0000)** to the following line items:

- **Contractual Services (#33300) – \$165,000.00**
- **Repairs to Buildings (#35450) – \$35,000.00**

As you may know, the medical services provider for both the Jail and the Juvenile Justice Center is now **Comprehensive Correctional Care (3C)**, following the contract signed in December 2024. In previous years, the Juvenile Justice Center was not separately recognized in the contract, and the Jail covered its medical expenses. However, due to increased costs associated with the new contract, the Jail is no longer able to subsidize the Juvenile Center's medical fees.

At the time of last year's budget discussions, the transition to a new medical provider was unforeseen. This requested transfer will cover essential costs, including:

- **A full-time nurse (40 hours per week)**
- **The Juvenile Justice Center's portion of the Cadmus medical software system**
- **The base cost of the medical contract**

Additionally, **\$35,000.00** is needed to cover the remaining costs of the **sally port expansion project**. During the initial architectural design, the security system was inadvertently omitted from the estimated renovation costs. These funds will provide and install:

- **A new IP security camera system** with associated cabling
- **Interior and exterior intercoms**
- **A door card reader** and necessary cabling for exterior access


**1161-33300 New Life Fellowship Compassion Ministries Food Pantry \$25,000**

New Life's Compassion Ministries Food Pantry mission is to provide nutritious food to individuals who struggle with hunger and promote public awareness about the growing hunger problem. They are a USDA Certified "Choice" Pantry, which means that individuals can shop for the foods they desire. In addition, the pantry provides other programs to help meet specific needs of children. This program provides food to meet basic nutritional needs.

Findings in Feeding America's Map the Meal Gap study:

In Indiana, food insecurity averages 13.9%. Vigo County is above the state aggregate at 16.8% in Vigo County.

Dear Joni Wise,

One of the challenges our pantry faces is having healthier food options. We strive to supply our guests with items that go together to make complete meals. Unfortunately, these are generally meals high in carbs such as pasta, or high in sodium such as canned vegetables, and processed meat.

We are a U.S. Department of Agriculture certified pantry that offer a morning and evening pantry and private emergency appointments. In March we served 193 families which translated into 590 individuals. As summer approaches these numbers will increase since families do not have access to school breakfast or lunch.

I wanted to provide a little background about the individuals we help, they are quite diverse. We serve a large number of elderly retirees and veterans on fixed incomes. Based on personal conversation with this group, we have found they are less likely to apply for SNAP and other assistant. Due to health issues, most would be better served with healthier options.

Many families we help are from Briar Ridge and Lata mobile home park, as well as Margaret Avenue and Lockport housing authority. These areas house a large percentage of individuals who are food insecure. We do serve a small number of Hispanic families. In addition, on Sunday, we prepare hot lunches for our seniors 70 years and older. This program is a separate budget; however, it is also funded through Compassion Ministries.

Our pantry's greatest need is fresh meat that is not processed. Next, fresh vegetables and fruit. It would be a great addition to offer at least one of the following items monthly: milk, bread, eggs, cheese, or peanut butter.

Based on current pricing, to provide at least one choice from each group of the aforementioned items we would need a minimum of **\$22,000** to finish out the year 2025. **\$23,500** would allow us to add 1lb rolls of ground turkey to provide a two meat options.
