Pledge of Allegiance

President Todd Thacker called the meeting to order at 5:00.

Calling of the roll

Present: Aaron Loudermilk, Nancy Allsup, Vicki Weger, Marie Theisz, Travis Norris, Todd Thacker, and David Thompson.

Correcting of the journal of the preceding meeting if needed

February 8, 2024 Sunshine Meeting

February 13, 2024 Meeting

There were no corrections to the minutes of the February 8, 2024 Sunshine Meeting. Marie Theisz made a motion to approve the minutes of the February 8, 2024 Sunshine Meeting. Vicki Weger seconded the motion. Upon a voice vote of 7-0, the motion unanimously passed.

There were no corrections to the minutes of the February 13, 2024 meeting. Vicki Weger made a motion to approve the minutes of the February 13, 2024 meeting. Nancy Allsup seconded the motion. Upon a voice vote of 7-0, the motion unanimously passed.

Communications from elected officials, other officials or agencies of the County

Council Attorney Michael Wright addressed a modification to the Rules of the Council that had previously been adopted on January 9, 2024, specifically Rule 12, Section 4 pertaining to the first reading of proposed resolutions and ordinances. This was created when the Council was assigning every request to a committee for a recommendation. This really does not have a place in the current method of Sunshine meetings. A sample of a prior agenda both before and after the proposed change had been provided to the Council. The amendment proposed tonight would do away with some redundancy in the format. This language is not necessary to conduct the meetings. President Thacker noted that according to the Rules, there would need to be a two-thirds favorable vote to make this amendment. Vicki Weger asked if there was any reason at all to keep this in the rules and Mr. Wright said in his opinion, there was not. There was a brief discussion. Vicki Weger made a motion to eliminate Section 4 of Rule 12 and amend the language of 6 and 7 to add "first reading" to the language of the 2024 Rules of the Vigo County Council. Marie Theisz seconded the motion. Upon a voice vote of 7-0, the motion unanimously passed.

Chief Deputy Auditor Cheryl Loudermilk said that a copy of the cash fund statement with the ending cash balances as of December 31, 2023 for all the operating funds had been provided to Council members. This had been produced after the final annual reports had

been uploaded to Gateway in order to start the annual review of the State Board of Accounts. The Auditor's Office could be contacted if there were any questions.

Ordinances relating to appropriations.

i. Amended Salary Ordinance 2024-21A: Courts – Budget Adjustment

The Annual Budget Committee had met about this matter and recommended that it be approved. Council had no further questions. Travis Norris made a motion to approve Amended Salary Ordinance 2024-21A. Marie Theisz seconded the motion. Upon a voice vote of 7-0, the motion unanimously passed.

ii. Additional Appropriation 2024-25: Veterans Assistance – Copy Machine Rental

This matter had been discussed at the Sunshine Meeting. Council had no further questions. Marie Theisz made a motion to approve Additional Appropriation 2024-25. Vicki Weger seconded the motion. Upon a voice vote of 7-0, the motion was unanimously approved.

iii. Additional Appropriation 2024-26: LIT/Special Purpose – Contractual Services

This matter had been discussed at the Sunshine Meeting. Marie Theisz thanked the Commissioners and Garmong Construction for meeting with members throughout the week to review all the information about the demolition. Vicki Weger said the Council had done substantial investigation of the building during the past week. Vicki Weger made a motion to approve Additional Appropriation 2024-26. Aaron Loudermilk seconded the motion. Upon a roll call vote, voting was as follows: Aaron Loudermilk – aye; Nancy Allsup – aye; Vicki Weger – aye; Marie Theisz – aye; Travis Norris – aye; David Thompson – aye; and Todd Thacker – nay. With a vote of 6-1 in favor, the motion carried.

iv. Additional Appropriation 2024-27: Parks Non Reverting – New Equipment

This matter had been discussed at the Sunshine Meeting. Travis Norris asked about a difference in the amount requested versus the cost of the equipment and Adam Grossman confirmed the amount. Nancy Allsup made a motion to approve Additional Appropriation 2024-27. Vicki Weger seconded the motion. Upon a voice vote of 7-0, the motion was unanimously approved.

v. Amended Salary Ordinance 2024-28A: Parks – Add 1 Full Time Position

This matter had been discussed at the Sunshine Meeting. Council had no further questions. Marie Theisz made a motion to approve Salary Ordinance 2024-28A. Vicki Weger seconded the motion. Upon a voice vote of 7-0, the motion was unanimously approved.

vi. Amended Salary Ordinance 2024-29A: Adult Probation – Amend Receptionist Position to Secretary

This matter had been discussed at the Sunshine Meeting. Council had no further questions. Aaron Loudermilk made a motion to approve Salary Ordinance 2024-29A. Vicki Weger seconded the motion. Upon a voice vote of 7-0, the motion was unanimously approved.

vii. Amended Salary Ordinance 2024-33A: Supplemental Adult Probation – Delete Secretary II Position

Since this matter had been discussed at the Sunshine Meeting, it had been noted that a change to the effective date to April 19 is being requested. This will allow some training to take place before the current employee retires. Doing so would require a motion to amend the Amended Salary Ordinance 2024-33A under consideration. Marie Theisz made a motion to amend Amended Salary Ordinance 2024-33A by changing the effective date to April 19, 2024. Vicki Weger seconded the motion. Upon a voice vote of 7-0, the motion unanimously passed. Marie Theisz made a motion to approve Amended Salary Ordinance 2024-33A as amended. Vicki Weger seconded the motion. Upon a voice vote of 7-0, the motion was unanimously approved.

viii. Amended Salary Ordinance 2024-30A: CASA – Amend Salary Ordinance and Correct Job Description

There was lengthy discussion about the staff advocate and their pay grade of 10 being changed to a lower grade. It was also discussed keeping the staff under discussion with a pay grade of 10 at that pay rate and increase her duties and keep her as a staff advocate supervisor. Aaron Loudermilk made a motion to amend Amended Salary Ordinance 2024-30A, part b by changing the title to Staff Advocate Supervisor with the position to remain at Grade 10 at \$26.63 per hour. Marie Theisz seconded the motion. Upon a voice vote of 7-0, the motion was unanimously approved. Marie Theisz made a motion to approve Amended Salary Ordinance 2024-30A as amended. Aaron Loudermilk seconded the motion. Upon a voice vote of 7-0, the motion was unanimously approved.

ix. Amended Salary Ordinance 2024-31A: CASA – Add 3 Full Time Positions

This matter had been discussed at the Sunshine Meeting. It was also noted that these positions would start out with 20 days of vacation. There was discussion about the effective date if this were approved. Marie Theisz asked for discussion to be had regarding the number of positions being requested. Timing for new grants being requested was also discussed. Marie Theisz made a motion to amend Amended Salary Ordinance 2024-31A from 3 full time positions to 2 full time positions. Aaron

Loudermilk seconded the motion. Upon a roll call vote, voting was as follows: Aaron Loudermilk – aye; Nancy Allsup – aye; Vicki Weger – aye; Marie Theisz – aye; Travis Norris – nay; David Thompson – nay; Todd Thacker – aye. With a 5-2 vote, the motion carried. Marie Theisz made a motion to approve Amended Salary Ordinance 2024-31A as amended with an effective date of October 1, 2024. Nancy Allsup seconded the motion. Upon a roll call vote, voting was as follows: Aaron Loudermilk – aye; Nancy Allsup – aye; Vicki Weger – aye; Marie Theisz – aye; Travis Norris – nay; David Thompson – nay; Todd Thacker – aye. With a 5-2 vote, the motion carried.

x. Amended Salary Ordinance 2024-32A: CASA – Correct Position Titles

There was a short discussion. Marie Theisz made a motion to approve Amended Salary Ordinance 2024-32A. Vicki Weger seconded the motion. Upon a voice vote of 7-0, the motion was unanimously approved.






Commissioner Mark Clinkenbeard expressed his appreciation to the Council for doing their due diligence regarding demolition of the old jail.
