#### **Change in Payment Addendum**

He had decided to go with Gordon Flesch for the new contract, but the new printer did not have a paper feeder that could hold five reams of paper. He said the Auditor's Office goes through a large amount of paper and the feeder would be necessary. The new monthly payment would change to \$526.14 from \$477.72. Chris Switzer made a motion to approve the change in payment addendum. Mike Morris seconded the motion. Chris noted for the upcoming budget cycle, discussions would be had about changing the ownership/rental process for county offices' printers.

#### **LOA for Aumentum**

County Assessor Kevin Gardner presented the Board with a Letter of Authorization for Aumentum Technologies. Kevin said Aumentum was the Assessor's Computer Assisted Mass Appraisal provider. He said Indiana code states they have to have their property record cards available online. He said Aumentum are the ones who create the PDF file with information that will eventually end up on Beacon. Chris Switzer made a motion to approve the Letter of Authorization. Mike Morris seconded the motion. The motion passed with a vocal vote.
