Mike Hambright approached the Board and said he runs a local tattoo shop. He said the interpretations of a tattoo ordinance by the Health Department were causing his business issues. He said the ordinance stated artists must be licensed in county for a year in order to sponsor apprentices and this was causing issues with his ability to run his business and sponsor his own apprentices. Mike claimed the ordinance does not match what was published online and requested his years active in Vermillion County should apply for Vigo County. Mark Clinkenbeard noted Health Department Ordinances were not the Commissioners decision, they merely adopt them after they are presented. Chris Switzer said the Commissioners would be in contact with Mike.

Chris Switzer said he had been in hearings with the Vigo County Council Annual Budget Committee. He thanked the Committee and the Auditor's Office for their efforts in the production of a budget for the County.
