Resolution 2025-10: Approving the Issuance of an Airport Revenue Bond of the Terre Haute Regional Airport

Airport Authority Attorney Scott Craig approached the Board and explained this resolution would give the airport permission to borrow \$600,000 via a bond. He said the bond will help with expenses related to a small solar project. He said the project cost \$2.6 million and they had received a \$500,000 grant alongside a \$1 million tax credit. He said the tax credit will be awarded after the project is complete. He said this resolution would essentially allow the airport to borrow \$600,000 from the Terre Haute Redevelopment Commission, and this approval by the Board would be one of several approvals needed from local government bodies. Scott gave a brief update on the status of the solar project. Mike Morris made a motion to approve Resolution 2025-10. Chris Switzer seconded the motion. The motion passed with a 3-0 voice vote.
