

Food Establishment Inspections
November 17, 2008 through November 21, 2008

Golden Corral #2499, 10 W. Johnson Dr., **(9 Critical, 10 Non-Critical)** – Lemons and oranges in food display in salad bar observed rotting and with mold; Pot roast, penne pasta, spinach, catfish, rotisserie chicken and pizza found at 111-132 degrees, should be 135 degrees or above; Baked beans in salad bar walk-in not marked with date of consumption; Found rack of cooked meats not marked with date of consumption; Found several dirty utensils in hot bar area; In front entrance area found dirty dishes on clean dish rack; Omelet station observed coated with grease; Pitcher, spoon, circular blade and stainless steel pan observed with food debris; Several drains leaking in dish area.

Jiffy Mini Mart #1, 1131 N. 3rd St., **(3 Critical, 1 Non-Critical)** – Wrapped sandwiches 50 degrees, milk 52 degrees in walk-in cooler, must be 41 degrees or below; No sanitizer and not sanitizing tongs for hot dogs; Sandwiches in warmer at 111 degrees with no time marking, should be 135 degrees or above or marked with time to discard.

Rally's #200, 129 S. 3rd St., **(3 Critical, 0 Non-Critical)** – Sliced cheeses at 54-64 degrees; No sanitizer measured in 3-bay sink; Spray bottles of cleaner hanging over 3-bay sink not labeled.

Fazoli's Restaurant #1659, 2930 S. 3rd St., **(2 Critical, 3 Non-Critical)** – Partially cooked pizza not marked for disposal; Clean pizza pans, plastic tubs, and stainless steel containers found greasy.

500 Express, 1240 Ohio St., **(2 Critical, 3 Non-Critical)** – Mac n Cheese wedges, cheese sticks, fried mushrooms, hamburger and corn dogs found at 113 – 125 degrees, should be 135 degrees or above; Sponge and plastic container found in handwash sink.

Holiday Inn, 3300 U.S. 41 S., **(2 Critical, 2 Non-Critical)** – Large sheet pans observed with greasy film; Spray bottle of cleaner not labeled.

Bob's Country Market, Inc., 4802 U.S. Hwy. 150, **(2 Critical, 0 Non-Critical)** – Pan of chili in cooler under deli case not marked with date of consumption; Piece of bacon strip and hot pad observed in handwash sink.

Harry & Bud's European Cuisine, 1440 S. 25th St., **(2 Critical, 0 Non-Critical)** – Eggplant, baked potatoes, and roasted peppers in cooler not marked with date of consumption; Rolling pin and seasoning containers found with accumulated debris.

Sam's Steakhouse, 2324 S. 3rd St., **(2 Critical, 0 Non-Critical)** – Chopped hard boiled eggs not marked with date of consumption; Found bottle containing green toxic substance not labeled.

American Legion Pioneer Post, 2149 Tippecanoe, **(1 Critical, 3 Non-Critical)** – Observed accumulated black debris on soda nozzle at bar.

T.K.'s Sports Grill, 724 N. Fruitridge Ave., **(1 Critical, 2 Non-Critical)** – Taco meat, chicken wings and baked potatoes not marked with date of consumption.

Speedway #6020, 743 Lafayette Ave., **(1 Critical, 2 Non-Critical)** – No sanitizer provided for coffee pots.

Great Wall, 100 N. 3rd St., **(1 Critical, 1 Non-Critical)** – At buffet, fried chicken wings, shrimp, potatoes and salmon found at 117-129 degrees, should be 135 degrees or above.

Pizza City #27, 315 N. 2nd St., **(1 Critical, 0 Non-Critical)** – Pizza pans/screens found with accumulated debris.

Hardee's #1500212, 200 N. 3rd St., **(1 Critical, 0 Non-Critical)** – Cooked sausage in cooler not cooled within appropriate time limits (discarded).
