Declare Surplus Equipment – Larry Robbins. Larry Robbins said he had some equipment that is no longer use at the Highway Department that he would like to declare as surplus and get rid of it and get it off their books. There are three vehicles, a skid steer, 3 rollers, a snow blade, a dump bed, a few asphalt trailers, and a damaged arrowboard. He'd like this to be declared surplus and sell it through GovDeals and see how that works out and then utilize that money to buy some new equipment. The arrowboard had been wrecked. It had been submitted to insurance and finalized. Right now it has some value but if they don't get rid of it in the sale, they will probably scrap it. There are a couple of things that they will have to work on getting titles for since they have been lost (i.e. the Jeep and one of the asphalt trailers is missing a title). There was discussion about how that is handled. Everything needed to list this on GovDeals is ready to go as soon as this has been declared surplus and will go live Friday. Mike Morris made a motion to declare the equipment surplus. Brendan Kearns seconded the motion. Upon a voice vote of 3-0, the motion unanimously passed.
