# RESOLUTION FOR ADDITIONAL APPROPRIATION OF FUNDS TO 2024 CUMULATIVE FIREFIGHTING BUILDING AND EQUIPMENT FUND

### (FUND 8691 - SPECIAL CUMULATIVE FIRE)

WHEREAS, the Honey Creek Fire Protection District of Vigo County, Indiana (the "District") contracts with the Honey Creek Department of Fire and Rescue Services, Inc. (the "Fire Department") for the provision of fire protection by the Fire Department within the geographical bounds of the Honey Creek Fire Protection District.

WHEREAS, the Fire Department was established 50 years ago, in 1974, as an all-volunteer fire department that responded to a fraction of the calls for emergency service it now responds to.

WHEREAS, the Fire Department's significant increase in responsibilities for the provision of emergency services over the past 50 years have necessitated the employment of a full-time staff of firefighters and administrative personnel and the acquisition of additional apparatus and other resources.

WHEREAS, the Fire Department is headquartered in the same building ("Station 91") from which it operated when the Fire Department was established a half-century ago.

WHEREAS, the space, amenities, and growing maintenance demands associated with Station 91 negatively impact the Fire Department's ability to operate efficiently and effectively.

WHEREAS, the District and the Fire Department believe it necessary to consider the feasibility of improving or replacing Station 91.

WHEREAS, given the capital expenditure that would be associated with improving or replacing Station 91, as well as the various technical factors that should be evaluated when considering the propriety of doing so, the District believes it prudent to retain the services of an expert capable of evaluating the necessary factors and offering reasonable and appropriate advice to help meet the Fire Department's needs.

WHEREAS, the District believes the retention of an expert to conduct an engineering and use study will permit the Fire Department and the District to make a fiscally responsible decision with respect to the renovation of Station 91 or the purchase or construction of a facility to replace Station 91.

WHEREAS, Indiana Code Sec. 36-8-14-2 permits the use of the District's

Cumulative Firefighting Building and Equipment Fund for the purchase, construction, renovation or addition to buildings.

WHEREAS, the Fire Department and the District estimate an engineering and use study with respect to the renovation of Station 91 or the purchase or construction of a facility to replace Station 91 will cost \$50,000.

WHEREAS, it is not within the presently-approved Cumulative Firefighting Building and Equipment Fund of the District to pay for an engineering and use study.

THEREFORE, BE IT RESOLVED by the District to seek an additional appropriation of \$50,000 to the 2024 Cumulative Firefighting Building and Equipment Fund to fund an engineering and use study with respect to the renovation of Station 91 or the purchase or construction of a facility to replace Station 91.

**BE IT FURTHER RESOLVED** that a copy of this resolution will be submitted to the Vigo County Council and the Department of Local Government Finance of the State of Indiana, and that the Vigo County Council will be asked to consider this request for additional appropriation at its next sunshine and regular meetings.

## RESOLUTION FOR ADDITIONAL APPROPRIATION OF FUNDS TO 2024 SPECIAL FIRE GENERAL FUND (FUND #8603)

WHEREAS, the Honey Creek Fire Protection District of Vigo County, Indiana (the "District") is responsible for providing fire and rescue services to the Vigo County Industrial Park I and the Vigo County Industrial Park II (collectively, the "Vigo County Industrial Parks").

WHEREAS, the Vigo County Industrial Park consists of industrial facilities located on 2,435 acres located within the boundaries of Dallas Road to the north, U.S. Highway 41 to the east, Oregon Church Road to the south, and Sullvan Place to the west.

WHEREAS, the District contracts with Honey Creek Department of Fire and Rescue Services, Inc. (the "Honey Creek Fire Department") for the provision of fire and rescue services across an area including the Vigo County Industrial Parks.'

WHEREAS, tax abatements granted to the owners of the facilities within the Vigo County Industrial Parks have limited the property tax revenue payable to the District, thereby limiting the funds available to the District to contract with the Honey Creek Fire Department for the provision of fire and rescue services to the Vigo County Industrial Parks.

WHEREAS, the funds the Honey Creek Fire Department receives by way of its contract with the District constitute the overwhelming majority of the funds utilized by the Honey Creek Fire Department to employ firefighters and otherwise operate.

WHEREAS, the Vigo County Redevelopment Commission (the "Redevelopment Commission") has committed to contributing the sum of \$150,000.00 in 2024 and the sum of \$150,000.00 in 2025 to the Honey Creek Fire Department to supplement the funds the Honey Creek Fire Department receives from the District.

WHEREAS, the funds to be contributed to the Honey Creek Fire Department by the Redevelopment Commission are intended to enable the Honey Creek Fire Department to hire and fund the employment of three (3) additional firefighters in 2024 and 2025.

WHEREAS, the District and the Honey Creek Fire Department believe the costs of employing three (3) additional firefighters will exceed the funds the Redevelopment Commission will contribute to the Honey Creek Fire Department.

WHEREAS, the District and the Honey Creek Fire Department believe an additional payment of \$25,000.00 from the District to the Honey Creek Fire Department will enable the Honey Creek Fire Department to satisfy the costs of employing three (3) additional firefighters in 2024.

WHEREAS, said payment of \$25,000.00 is not in the District's already-approved 2024

Special Fire General Fund budget.

THEREFORE, BE IT RESOLVED by the District to seek an additional appropriation of \$25,000.00 to the District's 2024 Special Fire General Fund budget.

**BE IT FURTHER RESOLVED** that a copy of this Resolution will be submitted to the Vigo County Council and the Department of Local Government Finance, and that the Vigo County Council will be asked to consider this request for additional appropriation at the Council's next-occurring sunshine meeting and regular meeting.
