Section 3 of Vigo County Code 3-58, SMOKING IN PUBLIC PLACES AND PLACES OF EMPLOYMENT, is hereby amended in its entirety as follows;

## Amended Section 3:

No person shall smoke in any place defined in Section 3-58-2 of the Vigo County Code except:

- a. Private residences, except when used as a licensed childcare, adult day care, or health care facility.
- Retail tobacco stores; provided that smoke from these places does not infiltrate into areas where smoking is prohibited under the provisions of this Chapter.
  - c. Outdoor areas of places of employment.

In addition to the provisions of section 3-58-2 of the Vigo County Code, Smoking shall be prohibited in all enclosed public places within Vigo County, including, but not limited to, the following places:

- a. Aquariums, galleries, libraries, and museums.
- Areas available to and customarily used by the general public in businesses and nonprofit entities
  patronized by the public, including but not limited to, professional offices, banks, laundromats,
  hotels, and motels.
- c. Bars.
- Bingo facilities.
- e. Convention facilities.
- f. Elevators.
- g. Facilities primarily used for exhibiting a motion picture, stage, drama, lecture, musical recital, or other similar performance.
- h. Health care facilities.
- i. Licensed childcare and adult day care facilities.
- Lobbies, hallways, and other common areas in apartment buildings, condominiums, trailer parks, retirement facilities, nursing homes, and other multiple-unit residential facilities.
- k. Polling places.
- Public transportation facilities, including buses and taxicabs, under the authority of Vigo County and ticket, boarding, and waiting areas of public transit depots.
- m. Restaurants.
- n. Restrooms, lobbies, reception areas, hallways, and other common-use areas.
- o. Retail stores.
- p. Rooms, chambers, places of meeting or public assembly, including school buildings, under the control of an agency, board, commission, committee or council of the Vigo County Commissioners or a political subdivision of the State when a public meeting is in progress, to the extent the place is subject to the jurisdiction of Vigo County.

- q. Schools.
- r. Service lines.
- s. Shopping malls.
- t. Sports arenas, including enclosed places in outdoor arenas
- u. Smoking shall be prohibited in all enclosed areas within places of employment. This includes, but is not limited to, common work areas, auditoriums, classrooms, conference and meeting rooms, private offices, elevators, hallways, medical facilities, cafeterias, employee lounges, stairs, restrooms, vehicles, and all other enclosed facilities.
