Public comment

Michael Wright, County Attorney updated the Council on a lawsuit filed in March of 2013 regarding the existing County Council precincts being unconstitutional. Sharon Russell believes her equal protection rights are being violated in regards to her vote being discounted based on her precinct being larger than the other precincts. The Indiana Code requires precincts to be as close as possible in population size. Mr. Wright responded to the lawsuit and sent it to the appropriate parties. He has also worked with Area Planning on a proposed reprecincting plan. This proposal has very few changes. Mr. Wright met with Ken Fulk, the attorney for the ACLU, and discussed the proposed plan. Mr. Fulk discussed the plan with his client and is agreeable to dismiss the lawsuit with prejudice and will not claim any attorney fees if the County adopts the reprecincting plan. This plan should not affect any current Council members' residency status in terms of taking them out of the district they currently represent. If agreeable, the statute requires the Auditor to call a special meeting to adopt a modified precinct plan.

Amend 2013 Salary Ordinance

Questions have risen regarding overtime pay for County employees in which the Council wishes to address. Michael Wright, County Attorney, explained the purpose of the addendum to the 2013 Salary Ordinance was to fairly compensate those employees who on occasion are required to leave their beds to deal with an immediate situation that is in the realm of public safety. After the Vigo County Highway Department left the union that previously represented it, it was Mr. Wright's opinion that these employees would then become employees subject to the Vigo County Handbook.

Motion: All Vigo County employees who are required to work in a public safety emergency as determined by the Vigo County Commissioners and/or their designee(s), outside the employee's scheduled shift shall be compensated at one and one half time of the employee's rate of pay for performance of their duties in the emergency, without regard to the total number of hours worked during that pay period. The specific emergency, authorizing signature and duration of the emergency must be included in documentation submitted to the Auditor's office with the employee's timesheet and shall be paid out in the period for which the emergency compensation was earned, **Action:** Approve, **Moved by** Tim Curley, **Seconded by** Ed Ping.
