Resolution and Addendum for Auditors Office and SRI- Certificate Sale. County Attorney Mike Wright presented the Board with a Resolution 2018-07 and Addendum for the Commissioners Certificate Sale. The Certificate Sale are properties that didn't sell in the Tax Sale and the County Commissioners set the bid at a lower price to get these properties to sell. Joe Edwards, Vice President of SRI was present and stated Vigo County has 855 properties in the Certificate Sale with a little over \$4 million owed in property taxes. Agreement for Emergency Medical Service- Transcare. County Attorney Mike Wright presented a new Agreement between Vigo County and Transcare. This is a 10 year Agreement whereas Transcare is willing to provide emergency ambulance service to Vigo County. **Motion: Action**: Approved, **Moved by:** Jon Marvel, Seconded by: Judith Anderson, **Passed**: all ayes.

Electronic Monitoring Service Agreement. County Attorney Mike Wright presented an Agreement between BI Incorporated and Vigo County for Community Corrections. This is a one year agreement. This is to upgrade the equipment to a better more reliable network. This will pick up any wireless network that is in the area. Bill Watson stated with this system they will be able to track through a private wireless network that they can't access but they can still be able to get a point off that person and still be able to track them through the secured system. This will be able to upgrade their technology from a 4G to a 5G. Bill Watson stated there is 155 on home detention and 5 are confirmed to go on monitoring this week. They stay between 150-160 people.
