- 2. That the Vigo County, Indiana Board of Commissioners shall conduct a public hearing to consider the assignment of the tax sale certificates on this 28 day of _______, 2019, at 9.00 a.m. in the Commissioners' Conference Room in the Vigo County Annex, Terre Haute, Indiana 47807.
- 3. That any objection or opposition to the proposed assignment described herein will be considered at the hearing.
- 4. That notice of the hearing described herein shall be published in accordance with IC 5-3-1.
