County Auditor James Bramble presented the Board with expenditures dated 05/19/2019 to 05/31/2019 in the amount of \$581,690.26 plus \$971,843.53 payroll for a total of \$1,553,533.79. **Motion: Action**: Approved, **Moved by**: Judy Anderson, **Seconded by**: Brad Anderson, **Passed**: all ayes.

Comment from Public or other Vigo County Representatives. Sister Dorothy and TJ Warren (CEO of the Valley Professionals) presented to the Board with a project she is working on in West Terre Haute. The County has \$29,954.82 in a fund for a previous project with Providence Housing. Sister Dorothy would like to declare the fund dormant and use this money for this project. The Housing Corporation now is making a Resolution to return the money back to the County General and in return appropriate it for Valley Professional Health Care Center for the purpose of building a medical clinic with a pharmacy. They have three lots right on 6th Street and National Ave in West Terre Haute. President Brad Anderson stated they would work on this and the County Council will assign it to a committee June 11 and then vote on it at the following Council meeting in August.

Pastor Dwayne Mallone discussed the job fair that the County held May 13. There were 90 applicants and he asked about a follow up on any of the available positions. He also discussed mental health programs and bail reform. There will be a meeting held June 26 at 6:30 in the Vigo County Library with ACLU.

Jerri Varner asked about a report from Garmong Construction concerning the report that the sheriff from Saginaw, Michigan gave describing the new plans for their jail.

Charlie Williams asked the Board about going to the highest price vendor and why there wouldn't be a third party.

Jim Kmetz commented to the board his support for them and the jail and to consider the plans from Saginaw, Michigan as they are not similar to our County's needs.

There being no further business, it is now ordered the Board be recessed.
