Amendment to Vigo County Code Section 24- Vigo County Auditor. County Attorney Mike Wright presented Vigo County Code Chapter 24 to be amended. This is a service fee for real property endorsement by County Auditor. As of July 1, 2019 this code will be amended. The Vigo County Auditor is required to collect a fee in the amount of \$10.00 for each deed or legal description for each parcel contained in the deed. Consideration of Contract Amendment- Vigo County Engineer. County Attorney Mike Wright and County Engineer Larry Robbins presented an amended contract with DLZ. This is an agreement to include pedestrian right of way evaluation and complete the ADA transition. The fee of the original Agreement is \$44,500.00 plus \$8,250.00 to the new fee of \$52,750.00 to the new Agreement. Consideration of Resolution of Draft form of Lease- Vigo County Attorney. County Attorney Mike Wright presented Resolution 2019-10 Indiana Preliminarily Approving the Leasing of Certain Jail Facilities and Taking Other Actions Regarding the proposed Lease. This project is a lease rental financing for the new county jail facility. It would be located at lot 1 of a subdivision of 500 West Honey Creek Drive Terre Haute, IN 47802. The Vigo County Building Corporation would actually own the asset and the County leases that asset back from the Building Corporation and when the debt is paid then the Building Corporation would transfer the assets back to the County. Consideration of Off-Road Vehicle Ordinance- Vigo County Commissioners. County Attorney Mike Wright presented an Ordinance Pertaining to the Operations of Off-Road Vehicles. This allows off road vehicles to be on county highways as long as the vehicle is registered and the driver is of 18 years of age or older with a valid driver's license. This does not pertain to city roads only county roads. This would be
