**Consideration of Bids Received on 2.7.20.** Larry Robbins, County Engineer, was present to discuss the bid opening for the Community Crossings Project bid opening and give his recommendation. Wabash Valley Asphalt was the sole bid received for asphalt. The total project included Sanford Road, Bowen Road, Eleana Road, Illinois Road, Bayh Road, French Drive, Sullivan Road, Lucerne Road, Dallas Drive and Milner Road. The total bid came to \$2,251,337.60. **Comment from Public or Other Vigo County Representatives.** Commissioner Anderson then introduced our new Juvenile Center Director, Norm Loudermilk. Mr. Loudermilk spoke briefly of future plans and invited any comments or future communications to be directed to him at any time.

A brief discussion was then had regarding properties in the tax sale. Topics discussed included location, total amount of delinquent taxes, various types of sales and the cost/amount of work that would be required to pursue other ways to collect/sell delinquent properties.

The next meeting will be February 18, 2020 at 9:00 a.m.




