The Vigo County Council approved and appropriated funds from the ISDH Immunization Grant awarded in the amount of \$95,283 to the Vigo County Health Department.

We had submitted our request to the VC Council to appropriate \$40,000 for Registered Nurse (R.N.) to work 35 hours per week at the current hourly rate of our full time R.N.'s. Under the Affordable Care Act, we were only able to work the currently grant funded R.N. up to 29 hours per week, because we failed to request funds for health insurance.

We would like to transfer funds currently appropriated for equipment to benefits to cover health insurance for the grant funded RN position and for the position to be re-defined as full time instead of part time.

Also, we would like to hire a 15 hour a week part-time clerical person at \$10.00 an hour to help with immunization insurance billing using. This person would be paid out of the current appropriation for personnel.


