information that is saved if anything was to happen. Jeremy also said that the IT Department has nothing to do with credit card information. If a department is to take a credit card that is up to that department to be responsible for their financial data. Also, the Vigo County website will be updated and changed. IT Department has been running a monitor in their department for the past 2 years that shows power consumption. They are down to less than .26 cents per kilowatts. County Commissioner Judith Anderson stated that Stephanie Yeger, Indiana Commissioner Association, asked to provide information on IT Security.

Bill Verdeyen commented to the Board that he went to a Riley Lake owners Association meeting last week. One of the home owners brought to his attention that he has a pipe under his drive way that is plugged up and it over flows and runs between two other houses.

Kylissa Miller commented that the County Council is getting ready to start budgets.

Kevin Richard commented to the Board that he has received several grass liens on his property and he was never notified to this problem due to incorrect mailing address.

Beth Fox turned in a petition to reevaluate and allow atv on public roads.


Bob Murray came in to introduce himself and he took the new position as the New Executive Director of the Tax Payers Association
