Resolution 2018-02 Saturn Petcare, Inc- Real Property- Final Action

Attorney Lou Britton represents Saturn Petcare, Inc. This new company will be at the old Pfizer Company location. This is a \$38.5 million project that will be hiring people with a starting pay of \$18 hour. They are requesting a 10 year abatement.

Ordinance 2018-02 Increasing Innkeepers Tax First Reading

County Auditor James W. Bramble read the first reading. The Innkeepers Tax is currently imposed at the rate of 6.5%. The act authorizes the Council to adopt a rate which is not to exceed 8% on the gross income derived from lodging income only. The Council determines that it is necessary to increase the Innkeepers Tax to a rate of 8%. The Council hereby finds that pursuant to the Act that there is a need to increase the Innkeepers Tax to a rate of 8% for the promotion and development and growth of the Convention and Visitor industry in Vigo County.
