Consideration of Bylaws for Criminal Justice Coordinating Committee. County Attorney Mike Wright presented the Vigo County Criminal Justice Coordinating Committee. The purpose of the committee is to serve as an advisory committee to the County Commissioners and County Council. The Committee is to give opinion toward improvements for resources and services for Vigo County. **Motion: Action:** Approved, **Moved by:** Jon Marvel, **Seconded by:** Brad Anderson, **Passed:** all ayes.

Expenditures. County Auditor James Bramble presented the Board with expenditures dated 09/29/2018 to 09/05/2018 in the amount of \$562,678.89. Plus payroll in the amount of \$882,856.01 for a total amount of \$1,445,664.90. **Motion: Action:** Approved, **Moved by:** Brad Anderson, **Seconded by:** Jon Marvel, **Passed:** all ayes.

Comment from Public or other Vigo County Representatives. Cliff Stephens Commander of Vigo County Veterans commented to the Board about the Veterans Memorial Park. The Veterans County Council has been given a 40 millimeter and air craft weapon from another American Legion that is closing. He is wanting to get permission to put this at the Park. In addition, the Vigo County Veterans Council is also having their dance and dinner this Saturday October 13, 2018. On October 20, 2018 there is a brick laying at 11:00a.m. at the Veterans Memorial Park.

Larry Davison commented to the Board about getting the jail site picked and built already.

Bill Verdeyen commented to the Board let's move forward with the jail.

Bob Murray asked the County Commissioners about the process of the new hires for the recreation of the jail.

Mike Esau asked the County Commissioners if the Board will post online the bylaws of the Criminal Justice Committee.

Dave Rarden commented that there have been rumors that the penitentiary stated they would sell the County 20 acres in order to place a new county jail on that property. He spoke with the assistant director about this and that was not valid.

Dwayne Mallone asked the County Commissioners why they decided to not have him part of the Criminal Justice Committee. He has also asked the County Commissioners if there is going to be any rehab programs for low level offenders and has there been any changes to hiring more of a diverse work force within Vigo County.

Susan Edmonson commented to the Board about placing more recycling dumpsters around the County to give people more recycling options.

Kevin Gardner commented to the Board no matter where they put the jail, do not put it at the Industrial Park.

Andre Kummerow asked the County Commissioners about putting the jail at the International paper mill site and also asked them about the criteria of the jail.

Donna Williams discussed the accessory use of the jail and also asked when the feasibility study would be posted to the public.

Charlie Williams asked about the second study of the jail and asked the County Commissioners to look more into having the jail at the Industrial park site instead of the International paper mill site.

Larry Robbins commented to the Board that Riley Road was paved yesterday.

There being no further business, it is now ordered the Board be recessed.


