***Budget Adjustment Committee***

***Additional Appropriation 2018-09 Drug Free Community***

Brandon Halleck, Vigo County Local Coordinating Council, requested to appropriate \$54,312 into Operating Expenses (1148.36700.000.0000) for the Drug Free Community Fund. This program is funded by court user fees paid via the Vigo County Clerk's office and City of Terre Haute Clerk's office.

***Additional Appropriation 2018-10 Health Donation***

Joni Wise, Administrator, requested an additional appropriation of \$5,500 to fund the new employee for the position of Health Educator for insurance. The previous employee utilized their spouse's insurance, so no insurance was appropriated for 2018 for this position. This position has been vacated and they are hiring from within the department. The insurance for this individual based on their status at 17 pays (start date of May 22, 2018) totals \$5,126.86. (4103.15230.000.0000)

***Additional Appropriation 2018-11 Court***

Judge Reddy requested an additional appropriation for \$150,000 to fund the Indigent Work Release Program. (1000.30044.000.0232) Gretchen Etling, Chief Public Defender, and Rob Roberts, Chief Deputy Prosecutor, appeared on behalf of Judge Reddy at the Budget Adjustment Committee. The request of the additional appropriation is for the Work Release Program and Bill Watson of Community Corrections wants it to include Home Detention. The Budget Adjustment Committee reduced the additional appropriation to \$75,000.

President Aaron Loudermilk called to amend Additional Appropriation 2018-11 due to the council packet was on the website for one day as \$150,000 instead of \$75,000.





