Comment from Public or other Vigo County Representatives. Tyson Cargal and Ernest Green are two managers of The Truman House Recovery. They came in to speak about The Truman House Recovery and described the program to the Board. It is a home for men of all ages designed to rehabilitate alcoholics and addicts. These men go through a twelve step recovery, behavior modification, peer support, mentoring, fellowship, and learn to embrace solution based thinking. They have two houses at the moment with 20 men enrolled in the program and are working on a third house north of Terre Haute. They will be hosting a fundraiser November 2, 2018 at the court house from 11-2 P.M., all proceeds go to the new house.

Jeremy Snowden commented to the Board about moving the internet services from the sheriff's office to the court house. Tonight IT will begin to start upgrading the hardware.
